## **LIMITED WARRANTY VON RUDEN MANUFACTURED HEAVY DUTY BLADE DRIVES (WALKER MOWERS)**

### **1. WHAT THIS WARRANTY COVERS AND FOR HOW LONG:**

Von Ruden will, at its option, repair or replace, without charge, any part covered by this warranty which is found to be defective in material and/or workmanship within one (1) year following the date that product is sold to the end-user so long as it does not exceed 18 months from the date stated on the Von Ruden serial tag or 1000 hours as indicated by the hour meter on such Walker Mower, whichever first occurs unless the product is used for rental purposes, in which case this warranty is limited to ninety (90) days. At Von Ruden's request, customer will make the defective part available for inspection by Von Ruden and/or return the defective part to Von Ruden, transportation charges prepaid.

### **2. WHAT THIS WARRANTY DOES NOT COVER:**

- A. This warranty does not cover defects caused by depreciation or damage caused by normal wear, accidents, improper maintenance, improper use or abuse of the product, alterations, improper gearbox mounting or support, or failure to follow the instructions contained in the Walker Owner's Manual for operation and maintenance.
- B. The customer shall pay any charges for making service calls and/or for transporting the gearbox to and from the place where the inspection and/or warranty work is performed.

### **3. HOW TO OBTAIN SERVICE UNDER THIS WARRANTY:**

Warranty service can be arranged by contacting the dealer where you purchased the mower or by contacting Von Ruden Manufacturing, Inc. Proof of the date of purchase may be required to verify warranty coverage.

### **4. WARRANTY LIMITATION:**

WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, VON RUDEN EXPRESSLY DISCLAIMS ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR ANY PARTICULAR PURPOSE, REGARDLESS OF ANY KNOWLEDGE VON RUDEN MAY HAVE OF ANY PARTICULAR USE OR APPLICATION INTENDED BY THE PURCHASER. THE SUITABILITY OF FITNESS OF THE PRODUCTS FOR THE CUSTOMER'S INTENDED USE, APPLICATION OF PURPOSE AND THE PROPER METHOD OF INSTALLATION OR MOUNTING MUST BE DETERMINED BY THE CUSTOMER. SOME STATES DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU.

B. Any legal proceedings arising out of the sale of this product must commence within eighteen (18) months of the serial tag date. Some states do not allow limitations on how long an implied warranty lasts, so the above limitations may not apply to you.

C. Von Ruden will not be liable for any incidental, consequential, or special damages and/or expenses in connection with the purchase or use of this drive. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation(s) or exclusions may not apply to you.

D. Only the warranty expressed in this limited warranty shall apply and no dealer, distributor, or individual is authorized to amend, modify, or extend this warranty in any way. Accordingly, additional statements such as dealer advertising or presentations, whether oral or written, do not constitute warranties by Von Ruden, and should not be relied upon.
